Commissioner Dias inquired about if three monument signs are allowed and what the distance between the two monument signs on Golden State Blvd. will be.

# 2. ORDINANCE AMENDMENT 2020-02 (CANNABIS ADVERTISEMENT AND SIGN REGULATIONS)

City Attorney Nubia Goldstein explained this ordinance is a recommendation to the City Council to approve an addition to the Title 9 sign regulations to limit the size, location and characteristic of signs pertaining to cannabis businesses.

Attorney Goldstein stated the signs would be limited to one, 2.5 foot tall wall sign and 25 square feet of sign area. The sign would only be permitted to display the business name, logogram, address, hours of operation, and contact information. The signs cannot contain cartoon characters, a cannabis leaf, plant, or images of cannabis accessory devises used to consume cannabis. All off-site signs, temporary signs or window signs will be prohibited.

Chairman Reape stated the amendment was what the Planning Commission was going for.

Commissioner Anderson asked what if the logo has a cannabis plant in it.

Attorney Goldstein answered the State prohibits these pictures in their logos.

Commissioner Souza thanked her for the work.

Commissioner Anderson asked there needed to be an amendment to Title 5 also.

Attorney Goldstein answered yes, there will be a change in title 5.

**Public Hearing:** Chairman Reape opened the public hearing. Hearing no one, Chairman Reape closed the public hearing.
